PepsiCo South Africa (Pty) Limited– Competition Terms and Conditions/Rules

- 1) **Application:** Please read the promotional giveaway terms and conditions (“**Terms**”) carefully. These Terms apply to everyone entering the Pioneer Foods Pty) Ltd (“**the Promotion**”).

- a. The winner will be contacted within 24 hours via the cell number that they entered into the competition.
- b. The judges' decision is final, and no correspondence will be entered into.

11) **Prize Delivery:**

- a. To claim their prize, the winner must provide the Promoter with a copy of their valid slip, their South African identity document or permanent residency permit, and proof of address.
- d. Prizes will only be awarded with proof of purchase (valid till slip)
- e. The prizes are not exchangeable and non-transferrable and not transferable for cash. At the Promoter's discretion and where for reasons outside the control of the Promoter the prize cannot be awarded, the Promoter may substitute the prize for something of comparable value or for cash.
